We affirm the trial court's dismissal with prejudice of the plaintiffs' actions to recover for personal injuries and property damage in a multi-vehicle accident. The parties stipulated to the facts of the case; the evidence adduced at trial did not add any facts; and the trial judge correctly ruled that the state highway department owed no duty to keep the road in question open. We hold, as did the trial judge, that because the state owed no duty to maintain the road, the Highway Department was not liable for injuries sustained. A state agency cannot be held liable under a theory of negligence merely because an accident has happened. See *Casher v. City of Tampa*, 265 So.2d 634 (Fla. 1972). The plaintiffs have made no argument that the Highway Department owed a duty to maintain the road under Florida law or the Florida constitution, and this appears to be an issue of first impression in Florida. The plaintiffs' only argument on this point is based on a theory of "special relationship". This issue is one of first impression in Florida as well. "Special relationship" is an evolving theory of liability in various jurisdictions, the elements of which depend upon the particular facts of each case. See, *F. Harper and F. James, Law of Torts* § 26.12 (1956). There is no Florida case or statute dealing with this theory of liability. The plaintiffs argue that the Highway Department had undertaken a duty by regulating traffic on the highway, citing *Alexander v. Coca-Cola Co.*, 146 Fla. 604, 1 So.2d 531 (1941), and *Cramer v. GAF Corp.*, 490 F.2d 128 (5th Cir.1974). However
